Renter agrees:

- No permanent adjustments (e.g., cutting, dyeing, stitching) are permitted.
- The garments will be kept clean, smoke-free, and dry at all times.

5. Cleaning & Maintenance

Unless otherwise specified in writing:

- Lender will handle all professional cleaning post-rental.
- Renter agrees not to attempt cleaning or laundering the garment themselves in order to prevent irreversible damage to the garment.
- An additional cleaning fee of \$_____ may apply for excessive wear, stains, or odors upon review of the Lender.

6. Damage, Loss, or Theft

A post-rental inspection will determine if damages occurred.

Minor damages (e.g., loose threads, small snags) will incur a reasonable repair fee.

Major damages, loss, or theft will result in full retail value charge minus the rental fee already paid.

Security deposit may be withheld in part or in full to cover such costs.

7. Late Returns

Garments returned after the agreed date/time will incur \$_____per day in late fees.

8. Ownership

All garments remain the sole property of the Lender.

Renter acquires no ownership rights regardless of rental period or payment made.

9. Liability
